Part I: Summary of Session I Results

Criss Sutton provided the group a review of the activities and discussions from session II. She presented the group with a list of goals that resulted from session II and opened the floor to a discussion. The group modified the language used in the goals to:

Part II: Presentation of Evidence Informed Interventions

A non-exhaustive list of 26 evidence informed interventions (EIP) were presented to the group. The interventions address priorities related to access to care, maternal health, and social determinants and ultimately impact infant mortality.

Criss Sutton also summarized survey results that included 22 ongoing or past EIPs and 17 EIP recommendations.

Challenges for implementation noted were:

- Sustainability
- Cost vs. funding to implement
- Staffing capacity
- Small population served
- Poor community uptake due to lack of support and/or poor marketing
- Low reimbursement rate

- Parents often want to hold infants and cosleep
- Availability of professionals and practitioners (social workers, lactation specialists, etc.)
- Adopting a new model for care
- Availability/accessibility of services

Observations include:

- All EIP address infant outcomes in some way
- Most address more than one goal, measures to address pre-term births, birth defects, and SIDS specifically.
- There is no priority that is not addressed through one or more EIP
- There was a significant amount of overlap in survey responses (recommendations/current practices) and HMHB EIP research
- The majority are national initiatives, in GA most are managed by public health

Part III: Objective Setting

Attendees then worked within their assigned groups to develop SMART objectives for a subset of priorities. Each group was asked to identify what needs to happen to support goal accomplishments using the following set of questions:





- a. What needs to happen in the next 3-5 years to this priority to accomplish the goal for the priority cluster?
- b. Who will participate?
- c. How can progress be measured?
- d. Based on the answers, develop one SMART objective for the priority.

After developing SMART objectives for each of the 13 priority areas, the group went around and provided feedback and input for next step activities.

Next Steps:

HMHB and the Georgia Health Policy Center will work to draft a report and request partner feedback by September. A final report will be drafted and circulated during a partner feedback and public comment period. HMHB is looking for partners to support a convening in 2018 to release the report and think about implementation strategies.
